### TLDEF to Honor Lowenstein Sandler LLP with Pro Bono Partner of the Year Award

#### Transgender Advocacy Awards Set for Tuesday, June 11, from 6:30 to 8:30 PM at the Manhattan Penthouse in New York City

(NEW YORK, NY - April 24, 2019) - Transgender Legal Defense & Education Fund (TLDEF) has announced the law firm Lowenstein Sandler LLP as its Pro Bono Partner of the Year. The award will be presented at this year's Trans Advocacy Awards on Tuesday, June 11, at the Manhattan Penthouse. The Trans Advocacy Awards serve as TLDEF's signature event that raises critical awareness and support for its work to advance equality for transgender and non-binary people nationwide.

Hintz, who has represented five clients through the Name Change Project.

This year marks the 50th Anniversary of Stonewall, and TLDEF will commemorate the milestone by producing a truly special event that celebrates its progress, spotlights community heroes, and raises vital funds to sustain and grow the organization's work. This is the first Transgender Advocacy Awards to be convened under the leadership of Executive Director Andy Marra, who was appointed to her position in November of last year.
