Over the past two decades, TLDEF has built its reputation as the legal arm of the trans rights movement in the United States, bringing needed attention to the epidemic of violence against transgender women, achieving groundbreaking wins, and making sweeping impact. TLDEF has fought against discriminatory policies around legal identification and around employment, defended the rights of trans people impacted by the carceral system, and advocated for just and dignified access to gender affirming health care - and we have claimed victory time and time again. All of this was accomplished by a handful of employees on a shoestring budget – and with the generous pro bono support of corporate partners along the way. In less than four years, TLDEF has grown from being an under one-million-dollar organization with one part-time lawyer to a budget of nearly \$4M and a staff of more than 25. The impact of the added capacity and financial resources is reflected in the legal and policy advocacy we can undertake, the active litigation we can manage, and the public education opportunities we can respond to – and we are just getting started.


